Charities Committee Report 2023



December 2023

Introduction

The Charities Committee's main task is to evaluate and select projects that have been submitted by registered parishioners so that the objectives of the projects can either be partially or fully sponsored, using the funds collected during the preceding Food Fair event.

After a multi-year break during the corona pandemic where the Food Fair wasn't held, the charities committee is now happy to resume its tasks following the resumption of a mini version in 2023.

Due to the reduced size of the Food Fair and expected lower collection, the guidelines for charity sponsorship at the start of the process were modified compared to previous years. In the table below, you will see what considerations were adopted for the 2023 process.

In 2023, we received 14 applications. We are glad to note that as part of the Go-Green initiative, over 95% of the applications were submitted digitally to the newly created charitiescommittee@parish.nl email address, thereby limiting paper wastage during the process.

Charity nomination submissions were initially closed on 31st August but was extended by 2-weeks to allow for late entries and collection of physical forms directed to the parish office.

The parish treasurer made € 20.000 available to disburse to successful projects. The amount was based on the net proceeds of the 2022 and 2023 Food Fair".

Ranking Process

The Charities Committee has been meeting every Saturday from 7th till 28th October 2023 to discuss and evaluate the different projects submitted. Part of the due diligence that the committee has been taking is to run through all the project details to check that they are not only genuine projects with knowledgeable sponsors but also deserving of the hard-earned collections from parishioners.

The selection criteria that the charities committee use to rank the nominated projects have remained unchanged throughout the years. The underlying principle is to ensure that the funds raised reach **maximum utility** - benefit the greatest number of people in a sustainable way. As a reminder, funds may only be requested for educational, spiritual, medical, agricultural, and social welfare projects but not for personal development. Preference is given to small, non-governmental self-help projects. We require projects to be yielding and self-sustaining, oriented to family and community development

We therefore rank allocation based on the following priorities.

- 1. Is the charity working towards lifesaving activities?
- 2. Does the charity benefit a large group of people (how far will our donation go)?
- 3. Is the charity work sustainable (has the community been involved and been invested) or will it require recurrent sponsorship?
- 4. Does the charity have alternate funding from other sources?
- 5. Has the project been supported by the church before?

The Charity Committee has scored the various projects based on merit and when allocating funds to the selected projects also evaluated whether a project could do with a less than what was originally requested in the application. As with prior years, the project reports were also reviewed during this years deliberations where applicable.


Ranking Outcome


In the table below, you will see the projects that have been ranked and selected based on the information provided from the sponsors and careful consideration from the charities committee.


